#### **Products Liability**

The maximum amount payable for any occurrence giving rise to any one claim or series of claims arising out of one cause during any one period of insurance. £3,000,000

#### **Territorial Limits**

Great Britain, Northern Ireland, the Isle of Man or the Channel Islands in connection with the business by you or any of your directors, partners or employees normally resident within the territorial limits.

## **Policy Endorsements**

### CSAF1 - Employee Definition

It is hereby noted that the definition of employee under the Public & Employers Liability sections are restated as:

Employee means any person under a contract of service or apprenticeship with the insured or supplied to or hired to or borrowed by the insured including any person under a work experience training scheme and including child carers, whilst engaged in work in connection with the business.

### CSAF2 - Exclusion of liability for deliberate acts (Vicarious Liability)

The following additional Special exclusion is incorporated into the Public Liability Section of this policy:

(The Company will not be liable under this Section in respect of)

15. loss, destruction, damage, accident or liability caused or happening through the deliberate, wilful, malicious or criminal act of the insured, or any employee of the insured, or any other person indemnified by this policy.

### Additional Special Conditions applicable to All Sections

For the purposes of this policy, the insured provide a babysitting and temporary non-regulated childcare service for families, at the family homes, hotels, holiday accommodation and other third party premises.

All babysitters/childcarers have been checked, interviewed and authorised by Sitters.co.uk, prior to being placed on their active childcarers list.

All placements are arranged by strictly pre-booked online or telephone bookings. Cover is not in place until Sitters.co.uk have confirmed that the booking is formally in place, with the client.

### Alterations to the Public Liability Section

1. Special exclusion 5 is amended to read as follows;  
5 liability arising from or caused by:
  - a) breach of professional duty
  - b) the provision of advice or any plan, design, formula or specification given separately for a fee
  - c) any diagnosis, therapy, medical advice, aerobic or other fitness related instruction given or performed
  - d) treatment (other than first aid treatment) given or performed
  - e) administration of drugs and medicines other than antibiotics, asthma inhalers, EPI Pens and those available without prescription and strictly in accordance with Special condition 2 Administration of drugs and medicines
  - f) the use of solaria, sunbeds, saunas and hydro-massage facilities
  - g) loss or destruction of or damage to property, buildings or land caused by vibration or by the removal or weakening of support.
  
2. The following Special condition is added:  
Special condition 2 Administration of drugs or medicines  
For the purposes of this Special condition the following words or expressions will carry the same meaning wherever they appear:  
parent                                  person with legally recognised parental or guardian responsibility

drug(s) or medicine(s)      drugs and medicines agreed under Special Condition 1)e

2      It is a condition precedent to our liability that the administration of drugs or medicines takes place only under the following conditions:-

(a)      the drug or medicine must have been given to you by the child's parent  
(b)      you must have a written authorisation which must be retained from the child's parent containing clear instructions for the administration the drugs or medicines and in the case of EPI Pens you will require a letter from the child's General Practitioner confirming any training required and for this to be undertaken.

(c)      the drugs or medicines must be kept in a secure place with access only by you

(d)      a clear label, with the child's name, must be attached to any prescription drug or medicine

(e)      for all drugs or medicines administered you will keep a written record of the

(i)      child's name

(ii)      drug or medicine administered

(iii)      date and time administered

(iv)      dosage administered

notify the child's parent of this information and record the time and date such notification was given.
